Campground Rules

1. The campground is open for bathers between 09:00 AM and 07:00 PM.

Day guests and swimmers should pay the entrance fee to the supervisor

(+41 77 447 16 38).

The Campground at Lake Greifensee in the municipality of Maur is owned by the Nature Friends Campground Cooperative at Lake Greifensee.

- 2. The campground is open from April 1st to September 30th. The camping season lasts from May 1st to August 31st. Camping and pitching tents are not allowed by law from October 1st to March 31st.
- 3. Quiet hours:
 - Sunday to Thursday: 10:30 PM to 07:00 AM
 - Friday, Saturday, and before holidays: 11:30 PM to 07:00 AM
 - August 1st: 02:00 AM to 07:00 AM
- 4. Electronic devices with speakers such as televisions, radios, etc. should only be used with headphones. Keeping toxic amphibians and reptiles, parrots, dogs, cats, and other larger animals on the premises is not allowed. Guide dogs for people with specific needs are permitted. Small animals must be kept in appropriate cages. Football and other games or equipment that may damage tents are prohibited throughout the area. Ball games are allowed in the volleyball field. The safety net must be set up and removed afterwards.
- 5. The access road is open for loading and unloading camping equipment. Private vehicles are not allowed on the campground. Trailers provided by the campground are available for transporting camping equipment.
- 6. Users of boats and surfers are referred to the cantonal regulations. The use of SUPs, canoes, and similar equipment, as well as surfing from our campground, is only allowed for campers.
- 7. No modifications to the campground are allowed without the permission of the board.

- 8. Season ticket holders are responsible for regularly mowing the grass directly around their tents during the season.
- 9. Only tents can be set up. No pitch allows tents wider than 5m. Foundations must be kept invisible.
- 10. Parking of cars is only allowed forward with a valid parking permit in the designated areas.

Only one permanent parking permit can be issued per tent. This parking permit is only valid for one car listed on the parking permit of the respective campground (including its guests). It must not be passed on to other campgrounds and/or their guests.

Upon agreement with the supervisor, cars without a permanent parking permit (seasonal campers, passersby, or guests) can also be parked. For these cars, a parking permit must be obtained upon arrival for stays longer than 3 hours.

A designated parking space is available for disabled visitors.

The parking permit must be placed clearly visible at the rear of the car. Even with a parking permit, there is no right to park if all spaces are occupied.

Regular overnight parking on the parking lot is not allowed.

- 11. Glass, metal, and PET can be disposed of for free in the municipality. All wastewater must be disposed of only in the designated sanitary facilities. Feeding of wildlife and birds should be avoided. Food residues and waste must be disposed of in the container using a garbage bag.
- 12. The reed belt is fully protected. Entering the reed belt, spreading green waste, and disposing of compost or peat from, e.g., flower pots, is strictly prohibited.
- 13. Open fires are only allowed at the designated fire pit. Only type-approved charcoal and gas grills are allowed for grilling in front of the tent. Setting off fireworks on the entire campground and in the adjacent fields is prohibited for safety reasons. On August 1st, bengal matches, volcanoes, or similar items are allowed only at specially designated locations
- 14. Campground users who violate the campground rules or behave in a way that damages the reputation of the Nature Friends may be expelled from the campground. Issuance of another season ticket may be refused.

Campers are obliged to inform their visitors about these regulations.
